

## **“Sands China Green Fund”**

### **2012/2013 annual environmental protection scholarship selection plan to apply for rules (interim provisions)**

Sands China Ltd. has cooperated with Macau Ecological Society to set up the “Sands China Green Fund”. The aims of this funding are using to foster the education work in environmental study like Ecological, Environmental Science, Environmental Engine, Environmental Management, Environmental Impact Assessment, Urban planning or biological technology, etc.

#### ➤ Candidate

The students are studying in "Ecological, Environmental protection, Energy saving, Water saving" and other ecological environmental science category course which is hold in mainland China, foreign universities or education institution. The student should be Macau residents. The candidate could be Full-time schools, Part-time schools, certificate or diploma course, etc.

#### ➤ Scholarships conditions

1. Curricula had to match the Macau structured as "World Leisure Tourism Center" and “Low Carbon” cities development.
2. Honest, trustworthy, conduct assessment good.
3. The student in undergraduate, Master and Doctor had to get the scores in the "good" or more than 80 scores in average school year. Certificate or diploma student had to get the scores in the "good" or more than 80 scores.
4. Undergraduate students, master students or doctor student must study in the relating courses. Certificate or diploma programs of the applicant shall complete the course in a year. The course should be more than 30 hours.

#### ➤ The scholarship category, level and awards standard

##### 1. Category and level

- (1) Undergraduate level reward quota ten person, each person can get Mop 3000, total Mop 30,000.
- (2) Master level or above reward quota five person, each person can get Mop 5,000, total Mop 25,000.
- (3) Doctorate-level or above reward quota three people, each person can get Mop 10,000, total amount Mop 30,000.
- (4) Certificate or diploma course reward quota thirty people, each person can get Mop 2,000, total amount Mop 60,000.

In addition, the scholarship students can obtain the practical training in the winter vacation and summer vacation period in the Macau Ecological Society.

## 2. Awards standard

The scholarship review principle will accord the average grade of school year and list the order from each applicant. Conditions including: How many people apply for a scholarship, candidates comprehensive quality and decision the final confirmed of the review committee.

## 3. Application methods

- (1) The applicant needs to submit written application material which includes a CD. The CD content includes the applicant past environmental protection work, school performance and participated in the scientific research of the experiment, any awards or honors from school, etc. The applicant had to fill in the form with "Sands China Green Fund Environmental Protection Scholarship Application Form". The Form can be downloaded in Macau Ecological Society website (<http://www.macaueco.org>). The applicant need to submit the grade report with the school affix (original and copy version).
- (2) All the application forms were submitted to the organizing committee after integration, the organizing committee will accord the number of applicant and the candidate and review form the organizing committee.
- (3) If the documents submitted are not neat or do not conform by the regulations, it should not be accepted. All the documents will be kept in file and not be returned.

## 4. The time for a scholarship to accept

2012/2013 Environmental Protection Scholarship of "Sands China Green Fund" will be applied from 01- Jul to 31-Oct 2013. Overdue will not be accepted. The result will be announced on December or released before each year. The organizing committee will announce the quota for each categories for next years.
