2. Scientific knowledge (20%)
3. Operability, promotional work, results(40%)
4. Beautification processing (10%)

VI. The Amount of Funding

The design score of 80 points or more (full marks for 100 points), will be sponsored by some of its publishing and printing costs (maximum \$ 50,000). In order to support and encourage the public to take part in this activity, such as
